5. Sealed or electronic bids must be submitted to the office of Katahari RuralMunicipality, Morang by hand/ courier or through PPMO website www.bolpatra.gov.np/egp on or before 12:00 noon on **2076/07/24**. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 PM on **2076/07/24** at the office of Katahari-3. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security, amounting to a minimum amount as specified in table below. Which shall be valid for 30 days beyond the validity period of the bid?
7. If bidder wishes to submit the Bid Security in the form of cash, bidder has to deposit cash in deposit account no. 2190303007102 of office of Katahari Rural Municipality Morang at Rastriya Banijya Bank Limited, Katahari Branch and submit bank deposit voucher along with the bid.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
